## **ANNOUNCEMENT COMPLETION OF ISSUANCE OF MID-TERM NOTES**

This announcement is made by China Longyuan Power Group Corporation Limited\* (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

Reference is made to the announcement of the Company dated 6 June 2024 on the poll results of the 2023 annual general meeting of the Company in relation to the approval of the issuance of debt financing instruments by the shareholders of the Company.

The Company has completed the issuance of the 2025 first tranche green mid-term notes (the “**Mid-term Notes**”) of the Company on 14 May 2025. The aggregate issuance amount of the Mid-term Notes was RMB1.5 billion with a term of 5 years, nominal value per unit of RMB100 and coupon rate of 1.89%. The interest shall be accrued from 15 May 2025.

Agricultural Bank of China Limited was the lead underwriter and Industrial and Commercial Bank of China Limited, Bank of China Limited, Industrial Bank Co., Ltd. and Bank of Jiangsu Co., Ltd. were the joint lead underwriters for the public offering of the Mid-term Notes. The proceeds raised from the Mid-term Notes are to be used for replacement of the Company’s own capital expenditure on the 2022 first tranche green mid-term notes.

This announcement does not constitute, or form part of, an offer or invitation, or solicitation or inducement of an offer, to subscribe for or purchase any of mid-term notes or other securities of the Company, nor is this announcement distributed to invite offers for any securities of the Company.
