ANNOUNCEMENT POWER GENERATION FOR JUNE 2025

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited* (the “**Company**”) for June 2025 on a consolidated basis amounted to 5,781,238 MWh, representing a year-on-year increase of 1.56% as compared with the corresponding period of 2024, excluding the impact of coal power, representing a year-on-year increase of 18.07%. During the month, the wind power generation registered a year-on-year increase of 4.15%, and PV power generation registered a year-on-year increase of 99.32%.

As of 30 June 2025, the total power generation of the Company for 2025 amounted to 39,652,477 MWh, representing a year-on-year decrease of 1.07% as compared with the corresponding period of 2024, excluding the impact of coal power, representing a year-on-year increase of 12.73%, in particular, the wind power registered an increase of 6.07%, and PV power registered an increase of 71.37%.
